WHEREAS





### 2. General Terms of MOU





3.1 The parties assume that this agreement does not go against the rules and regulations of the Government of Manipur.





**Article 3.** This agreement will be effective for a period of five years from the date of its signing and the renovation will be requested for the period unless otherwise specified by the signing institutions.


**Article 4.** This agreement does not imply any financial duty upon both the institutions.



2. *Information Exchange*



## 2. Objectives, Scope, and Major Activities

The main objective of the MoU is to implement and execute the PARAMARSH Scheme.

- To promote quality assurance in Higher Education Institutions
- To enhance the overall quality of the mentee institutions and mentoring the Non-Accredited Higher Education Institutions □ To enable them to get accredited.
- To enhance the mentee institutions' quality and its profile as a result of improved quality of research, teaching and learning methodologies.
- The mentee institution will also have increased exposure and speedier adaptation to best practices.

The Scheme will be operationalized through a "Hub & Spoke" (H&S) Model where in the Mentor Institution, called the "hub" is centralized and will have the responsibility of guiding the Mentee institution through the secondary branches, the "spoke" which are the additional services provided to the mentee for self improvement. This will allow a centralized control over operational efficiency, resource utilization to attain overall development of the mentee institution. Hub can also be conceived as a pool of experts from multiple resources. External members can also be solicited from the industry and can be used as a resource pool. They can make a ground assessment and can have a clear action plan for mentoring.
